**CONCERNING: SUPPORT FOR THE INTER-TRIBAL COUNCIL OF NEVADA  
DOMESTIC VIOLENCE PROGRAM:**

**WHEREAS,** The Summit Lake Tribe is organized, pursuant to Section 16 of the Indian Reorganization Act of June 18, 1934 ( Stat. 984 ) as amended, with the Article of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Council; and

**WHEREAS,** The Summit Lake Tribal Council as authorized pursuant to the articles of Association of the Summit Lake Paiute Tribe, Article II, Section 1 ( J ); to determine its own rules of procedure; and ( K ), to that such actions as are necessary to carry into effect any of the foregoing powers and duties; and

**WHEREAS,** in accordance to Article II, Sec 1 (b); to represent the Summit Lake Paiute Tribe in negotiation with Federal, state, and local government, and other corporation, associations, partnerships or individuals, and to cooperate with the Bureau of Indian Affairs, Department of Public Health, and various departments and agencies of the State of Nevada in matters of welfare, education, recreation, and social services; and

**WHEREAS,** the Inter-Tribal Council of Nevada has applied for funding through the Department of Health and Human Services, and

**WHEREAS,** said funds are available to Indian Tribes and Indian Organizations to assist in establishing, maintaining and expanding programs and projects to prevent family violence to provide immediate shelter and related assistance for victims of Family Violence Prevention Services Act; and

**WHEREAS,** funds available shall not effect Summit Lake Paiute Tribe funding outreach for victims; and

**NOW THEREFORE BE IT RESOLVED,** the Tribe Council of the Summit Lake Paiute Tribe dose hereby submit Resolution SL-05-07 in support the Inter-Tribal Council of Nevada's Domestic Violence Program to the Department of Health and Human Services.
