CONCERNING: INHERITANCE OF LESLIE MILLER'S LAND ASSIGNMENT ON
THE SUMMIT LAKE INDIAN RESERVATION, NEVADA; FOR TRIBAL MEMBER
CHRISTINE P. HARJO

WHEREAS, the Summit Lake Paiute Tribe hereafter "Tribe" is organized pursuant to
Section 16 of the Indian Self Determination Act of June 1934 (48 Statue 984) as amended
with Article of Association of the Summit Lake Tribe approved by the Secretary of
Interior on June 08, 1965, granting certain powers to the Summit Lake Tribal Council
"hereafter "Council"; and

WHEREAS, the Council hereby is authorized in accordance with Article II, Sec 1 (c) of
the Articles of Association; acquire, manage lease, or otherwise deal with tribal assets;
and

WHEREAS, in Article II, Sec 1 (f) to make assignments of Summit Lake Reservation
lands or interest therein and property improvement thereon; and

WHEREAS, the Summit Lake Paiute Tribe has established Title 1 Ordinance No. IV
Land Assignments; and

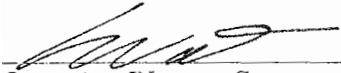
WHEREAS, former issuance of Inherited Land Assignment of Leslie Millers; Judy
Miller; whom Land Assignment Revoked due to current Land Assignment Ordinance No.
IV; qualification not being met accordance to policies and procedures; and

WHEREAS, the Tribe best interest for Inheritance of Land Assignment of Leslie Miller
be heir to his Estate: Daughter of Mr. Miller; and Tribal Member Christine P. Harjo; and

NOW THEREFORE BE IT RESOLVED, Summit Lake Paiute Council hereby approves
Inheritance of Leslie Millers land assignment: to be issued to Tribal Member and Heir to
Leslie Millers Estate: Christine P. Harjo.
