RESOLUTION NO.: SL-06-2013

TITLE: Approval of 2013 Bureau of Indian Affairs Range Noxious Weed Funding

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, the Summit Lake Paiute Council has the responsibility for the general welfare of its tribal membership including tribal natural resources; and

WHEREAS, the Summit Lake Paiute Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute Reservation; and

WHEREAS, the Summit Lake Paiute Council has been organized to represent, develop, protect and advance the views, interests, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and

WHEREAS, the Summit Lake Paiute Council has organized a Natural Resource Department to provide technical expertise and services to manage air, water, soil, fish, wildlife, and plants within the Summit Lake Paiute Reservation and off-reservation areas considered the aboriginal homeland of the Summit Lake Paiute Tribe; and

WHEREAS, the Summit Lake Paiute Council supports management to protect, conserve, and enhance plants and wildlife endemic to the Summit Lake basin and aboriginal are of the Summit Lake Paiute Tribe: and

WHEREAS, the Summit Lake Paiute Tribe submitted a grant proposal to the Bureau of Indian Affairs for noxious weed control in 2013; and

WHEREAS, the Bureau of Indian Affairs awarded \$66,327 to the Summit Lake Paiute Tribe to perform noxious weed control in 2013 with insufficient time to implement noxious weed treatment as proposed.

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council

approves the use of the above funding for the purpose of noxious weed control pursuant to Public Law 93-638, with the following terms and conditions:


1. The Tribal Officials authorized to submit, negotiate and execute the grant and any amendments, thereto, shall be the Tribal Chairwoman, the Council Secretary/Treasurer, and the Natural Resources Department Director.
2. The authorities granted by this resolution shall remain in effect until such time the grant is closed out.
3. The Tribal Chairwoman, Council Secretary/Treasurer, and the Natural Resources Department Director are authorized to make any and all necessary expenditures consistent with the intent of the noxious weed grant in accordance with the Fiscal Policies of the Summit Lake Paiute Tribe.
