RESOLUTION NO.: SL- 07-2015

TITLE: Enrollment, Itzochitl Genoa Conway

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, in the Summit Lake Articles of Association, Article II-Section 1(h); To establish a membership roll, enact regulation governing the loss of membership, future membership, and the adoption of members into the Summit Lake Paiute Tribe, but any member by written instrument may resign from the Summit Lake Reservation without prejudice to any action of the Summit Lake Paiute Council therefore, duly taken affecting his interest.

WHEREAS, in Article II-Section 1(j); to determine its own rules of procedure; and

WHEREAS, in Article II-Section 1(k); to take any actions as are necessary to carry into effect any of the foregoing powers and duties; and,

WHEREAS, the Summit Lake Council has adopted Summit Lake Paiute Tribe Enrollment Procedure Ordinance No. VII; and

WHEREAS, the Summit Lake Council reviews applications for enrollment pursuant to Section 5 of the Enrollment Procedure Ordinance; and ,

WHEREAS, Itzochitl Genoa Conway, Birth Date January 22, 2015, has requested to be enrolled member of the Summit Lake Paiute Tribe; and,

WHEREAS, Itzochitl Genoa Conway has been determined to be eligible for enrollment having met the required blood quantum of the Summit Lake Paiute Tribe.

BE IT FURTHER RESOLVED that the Summit Lake Paiute Council has approved Itzochitl Genoa Conway request for enrollment in the Summit Lake Paiute Tribe effective June 20, 2015.
