**RESOLUTION NO.: SL-19 -2015**

**TITLE: Special K-12 Student Services Education Program**

**WHEREAS,** the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Council; and

**WHEREAS,** the Summit Lake Paiute Council is the duly constituted governing body within the boundaries of the Summit Lake Paiute Reservation; and

**WHEREAS,** the Summit Lake Paiute Council has been organized to represent, develop, protect and advance the views, interests, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and

**WHEREAS,** The Summit Lake Paiute Tribe's Articles of Association grant to the Summit Lake Paiute Council certain sovereign powers, including providing educational supplemental assistance to Tribal Members; and

**WHEREAS,** Funding amounts vary from year to year, educational supplemental assistance will be based on each year's funding availability; and

**WHEREAS,** the Program is designed to provide assistance to students who are maintaining a minimum "C" grade point average and are exhibiting an acceptable attendance record; and

**WHEREAS,** a requirement for approval is a completed K-12 Student Services application packet. Application packet consists of: 1) a letter from the parent/guardian describing the student's needs; 2) a K-12 Student Services Application; 3) a K-12 Student Services School Verification; 4) Legal document showing custody/guardianship of student (if applicable); and 5) a copy of the student's most recent report card.

**WHEREAS,** and without prejudice towards the student or families seeking educational assistance through the Student Services Education Program.

**NOW THEREFORE BE IT RESOLVED** that the Summit Lake Paiute Council approved the Special K-12 Student Services Education Program for enrolled tribal member students; and,

**BE IT FURTHER RESOLVED** effective January 01, 2016, the Summit Lake Paiute Tribal Council authorizes the Education Committee to initiate the process of approving eligible students for educational supplemental assistance by procuring educational supplies and processing receipt/documents to the Finance Department for payment to approved vendors.
