**RESOLUTION NO.: SL-24-2015**

**TITLE: Amending Enrollment Committee Guidelines**

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48) Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers to the Summit Lake Paiute Council; and

WHEREAS, the Summit Lake Tribal Council as authorized pursuant to the Articles of Association of the Summit Lake Paiute Tribe, Article II, Section 1 (b) To represent the Summit Lake Paiute Tribe in negotiations with Federal, State, and local governments, and other corporations, associations, partnerships or individuals, and to cooperate with the Bureau of Indian Affairs, Department of Public Health, and various departments and agencies of the State of Nevada in matters of welfare, education, recreation, and social services; (j) To determine its own rules of procedure; and (k) To take such actions as are necessary to carry into effect any of the foregoing powers and duties; and

WHEREAS, the Articles of Association proscribe conditions to appoint committees (see Article V, Section 5); and

WHEREAS, the Enrollment Procedures Ordinance enacted by Resolution SL-17-89 also states the duties to be fulfilled by the enrollment committee (see Enrollment Ordinance, Article III, Section 1,2,3) appointed by the Summit Lake Paiute Council.

WHEREAS, the Council wants to amend the Enrollment Committee Guidelines enacted December 19, 2015 at the Council Meeting by adding the Processing Enrollment Applications Article III, Section 1,2,3.

NOW THEREFORE BE IT RESOLVED, the Summit Lake Paiute Council, the governing body of the Summit Lake Paiute Tribe, hereby approves Amending Enrollment Committee Guidelines.
